



## INSTRUCTION TO REJECT TRANSACTIONS

The undersigned holder of the card or checking account specified below does hereby instruct Automated Systems America, Inc., a Delaware limited liability company ("ASAI"), to reject any cash advance transaction requested using the card or checking account. Cardholder/Acct-holder is making this instruction pursuant to the Transaction Exclusion Program initiative of ASAI's Responsible Gaming Program and understands that this instruction may only be revoked using the written form of revocation. This instruction shall become effective upon ASAI entering the Card/Account information into its computer systems as a card/acct subject to a reject instruction and shall remain in effect until ASAI removes the Card/Account from its computer systems as a card/acct subject to a reject instruction following ASAI's receipt of a written revocation of such instruction using the form attached hereto.

Cardholder represents and warrants to ASAI that Cardholder has all right, power and authority to make this instruction on behalf of all joint holders of the Card(s). The undersigned authorizes ASAI to obtain credit reports using the information provided herein for the purpose of verifying the undersigned's identity and authority to make this instruction. Cardholder agrees that ASAI's acceptance of this instruction would be solely as an accommodation to Cardholder, without any consideration to ASAI; therefore, in no event shall ASAI bear any liability for its acceptance, rejection, compliance or non-compliance with this instruction or any revocation thereof for any reason whatsoever. Cardholder hereby waives any claims against ASAI in connection with this instruction or any revocation thereof, including without limitation ASAI's rejection of transactions pursuant to this instruction, ASAI's failure to comply with this instruction or ASAI's rejection of transactions prior to the effectiveness of any revocation of this instruction, and Cardholder agrees to indemnify ASAI against any liability arising from or relating to this instruction or any revocation thereof, including, without limitation, any liability to any joint holders of the Card(s), VISA U.S.A., Inc., MasterCard International, Inc., Discover/Novus Inc, any debit network, the issuer of the Card(s), any acquiring or merchant bank involved in the processing of transactions involving the Card(s) or any gaming establishment.

Check Account holder represents and warrants to ASAI that account holder has all right, power and authority to make this instruction on behalf of all joint holders of the Checking account. The undersigned authorizes ASAI to obtain credit reports using the information provided herein for the purpose of verifying the undersigned's identity and authority to make this instruction. Account holder agrees that ASAI's acceptance of this instruction would be solely as an accommodation to Account holder, without any consideration to ASAI; therefore, in no event shall ASAI bear any liability for its acceptance, rejection, compliance or non-compliance with this instruction or any revocation thereof for any reason whatsoever. Account holder hereby waives any claims against ASAI in

connection with this instruction or any revocation thereof, including without limitation ASAI's rejection of transactions pursuant to this instruction, ASAI's failure to comply with this instruction or ASAI's rejection of transactions prior to the effectiveness of any revocation of this instruction, and Accountholder agrees to indemnify ASAI against any liability arising from or relating to this instruction or any revocation thereof, including, without limitation, any liability to any joint Accountholders, TeleCheck, any acquiring or merchant bank involved in the processing of transactions involving the Check Account or any gaming establishment.

Cardholder/Checking Accountholder agrees that this instruction and any revocation thereof shall be governed in all respects by the laws of the State of California, without regard to any conflicts of laws provisions which may result in the application of the laws of any jurisdiction other than the internal law other the State of California. Card/Account holder agrees that any claim or controversy arising out of this instruction or any revocation thereof shall be settled by final and binding arbitration under the Commercial Arbitration Rules of the American Arbitration Association in Los Angeles County in the State of California by three arbitrators, one of whom shall be selected by ASAI, one of whom shall be selected by Card/Account holder and the third of whom shall be selected by the mutual agreement of the other two arbitrators. Judgment on any award rendered by the arbitrators may be entered in any federal or state court located in Los Angeles County in the State of California. The arbitrators shall award to the prevailing party, if any, as determined by the arbitrators, all costs, fees and expenses of such arbitration, including attorneys' fees.
